Terms and condition for enlisting kitting agents/supplier.

1. Technical Condition:-

- (a) The applicant should have previous experience in supply of kits to Govt. institution/PSU's
- (b) The applicant should have supplied successfully kits minimum worth of Rs. 50.00 lakh to PSU/Govt. authorities or any other department.
- (c) Performance certificate or orders from the authorities to whom kits have been supplied need to be submitted along with the application.
- (d) The applicant should submit copy of the valid wholesale license issued under the Drugs & Cosmetic Act by competent authority.
- (e) The kits should be supplied on warranty/Guaranty basis.
- (f) The kits shall be inspected by Rajasthan Drugs & Pharmaceuticals Ltd., and Govt. authority, if required prior to acceptance of supplies.
- (g) The applicant will have to provide an undertaking regarding quality and quantity of the items supplied in the kits. In case of medicines procured for the kits, the items should be obtained from schedule M/ schedule T holding companies as applicable.

- (h) The minimum numbers of batches of medicines/material should be made so as to get the analysis report submitted in time.
- (i) The applicant should offer on the basis of marketed by Rajasthan Drugs & Pharmaceuticals Ltd., please note that the word “ Marketed by Rajasthan Drugs & Pharmaceuticals Ltd.,” is marked on each kit (if the required products are procured from other sources).
